# Health Care

## General description of the Health Care Situation

Health care in Macedonia is relatively easily accessible (geographically, economically and time-wise), because it is delivered within a widespread network of public and private health care institutions. In this line, around 90% of the population can reach a health care institution in less than 30 minutes.

Like in many other countries, the health care system in Macedonia is oriented towards primary health care as a basis of the system, where the first contact with the health service is made and where the majority of the health care needs of the population are satisfied.

Patients who need health care at higher level are referred by the primary health care doctor to ambulatory-policlinic treatment or hospital treatment.

## Conditions for the coverage of medical treatment including details on the opportunity to access public services and health insurance

The health protection, particularly for those belonging to socially vulnerable categories, is regulated with the recent amendments of the Law on Health Protection, which introduced compulsory health insurance for all Macedonian citizens who previously did not have any grounds for obtaining health insurance. In this light, in order to obtain health insurance, the person needs to register in the local office of the Health Insurance Fund.

At the same time, each person that is registered at the Employment Service Agency (ESA) as unemployed person is entitled to health insurance. The Law on Health Insurance foresees compulsory health insurance coverage for temporary unemployed person while receiving unemployment financial support and unemployed persons that are actively seeking employment and regularly register with the Employment Service Agency, if there are no other grounds for insurance.

## Health Insurance Contributions for unemployed persons

- a) The Ministry of Health covers 100% of the health insurance contributions for the unemployed persons whose:
  - a. Yearly family incomes are below 96,600 Macedonian Denars (MKD) (ca. CHF 1900)
  - b. Yearly family incomes are between MKD 96,600 and MKD 183,546 (CHF 1,900- CHF 3,630), but the family incomes for the last two months are not more than MKD 16,100 (CHF 318).
- b) Unemployed persons whose yearly family incomes are from MKD 96,600 to MKD 183,546 participate in the health insurance contribution with approximately MKD 1,100 (ca CHF 22) per month.
- c) Unemployed persons whose yearly family income is more than MKD 183,546 participate in the health insurance contribution with approximately MKD 2,200 (ca. CHF 44) per month.

## Special services for the Roma population

Of particular importance are the preventive medical examinations with special focus on women and children, systematic examinations for children, immunization and coverage of part of positive list of drugs which are **available to the population regardless of the health insurance**. The Roma population particularly benefits from this set of measures. From the perspective of the geographical

location, the health care institutions are relatively easily accessible by the Roma population. Additionally, the Roma population can benefit from the services of the Roma Health Mediators i.e trained persons that facilitate the access of the Roma Community to the basic health and social services and provide health related advise. Precisely, the Roma Health Mediators provide the following services: individual and family health counselling; assist in establishing contact with the health and social institutions; if necessary, accompany the vulnerable Roma to the health care institutions; provide support in obtaining the necessary documentation, such as ID card, birth certificate and health insurance; provide explanation on the patients' rights and obligations; provide assistance related to vaccination and immunisation of children and counselling on the basic health issues. The Roma Health Mediators also offer their assistance through "door to door" visits of the Roma community. They can be contacted at the following telephone number: + 389 2 651-955.

The responsible party for payment of the health benefits for the employed persons is the employer, while self-employed persons should be covering the health insurance contributions by themselves.

After becoming entitled to access the system of social protection, right to health protection is also granted to persons who have acquired the right to permanent financial support; those staying in a foster family or a social protection institution; beneficiaries of financial support for care and support; persons who have had the status of children without parents and parental care before they turned 18 years in case they cannot be insured on another grounds.

Apart from the compulsory insurance, there is a possibility for voluntary health insurance for particular types of health services, namely services that are not covered with the compulsory health insurance.

### **Availability of medicines**

Medicaments are provided through a wide network of private pharmacies. The medicaments that are on the positive list are covered by the Health Insurance Fund (HIF). If a medicament is not on the list, it will not be reimbursed unless in individual cases with special permission from the Health Insurance Fund. The list of medicaments on the positive list is available at the website of the Health Insurance Fund: <http://www.fzo.org.mk/>. The medicaments can be sponsored by the Health Insurance Fund only on the basis of prescription. The prescriptions have to be written by the public or private health care institutions that have a contract with the HIF. In order to be reimbursed, prescriptions need to be filled through pharmacies that have a contract with the HIF.

## **Housing**

### **General description of the housing situation**

According to the last census Macedonia has 557,254 households. The average number of household members decreased in the past 70 years, from 5.79 to 3.85. The average dwelling surface in Macedonia is 71 m<sup>2</sup>, with an average of 21 m<sup>2</sup> per person. At present local governments are competent in the sector of urban planning, while the land ownership issues and building/construction licenses/permissions are part of the central government authority.

In terms of purchasing, the prices per m<sup>2</sup> in the capital vary from 800 to 1,300 EUR which is mainly interlinked to the location of the dwelling. The prices per m<sup>2</sup> in the towns outside Skopje are lower and vary from 600 EUR to 800 EUR per m<sup>2</sup>.

There is a large number of real-estate agencies in Macedonia which cover the whole territory of the country or operate in a certain town. Various information regarding opportunities of buying real estate can be found online <http://www.pazar3.mk/>.

Socially vulnerable groups can benefit from various policy measures, such as emergency shelter, financial support for social housing, social apartments and other support.

### **Requirements to obtain a place to live from the social services or emergency shelter**

Returnees without place to stay are temporarily accommodated in a Reception Centre for a period of up to 60 days. The Reception Centre offers accommodation, food, proper hygienic and sanitary conditions, as well as free counselling and other social protection services. After the initial short-term accommodation period and after all necessary personal documents are procured, returnees will be in a position to realize all their rights identically as the rest of the citizens of Macedonia, and if meeting the **below described** legal criteria to use the rights guaranteed through the protection systems. One of these rights is the right to social housing for vulnerable groups, defined with the existing legislative framework [http://www.mtsp.gov.mk/WBStorage/Files/zakon\\_so\\_zastita\\_osnoven.pdf](http://www.mtsp.gov.mk/WBStorage/Files/zakon_so_zastita_osnoven.pdf).

### **Availability of social grants for housing**

The Article 83 of the Law on Social Support envisages financial support for social housing to the socially vulnerable population without accommodation. The socially vulnerable persons are:

- Beneficiaries of permanent social support - persons not able to work, materially unsecured, who cannot secure means for their existence on the basis of other regulations. Persons not able to work are those with mental development disabilities who were not able to acquire education and those with physical disabilities unable to work; persons who due to their health situation are not able to work; single women during the pregnancy period-one month before the delivery; self-sustained parent in line with the Law on Family up to 3 years of age of the child; persons older than 65 years of age.
- Person that up to 18 years of age had a status of a child without parents and without parental care can be a beneficiary of financial support for social housing up to 26 years of age.

Of particular importance is the Governmental social apartment's project. The beneficiaries of social apartment's project include: persons that up to 18 years of age had a status of children without parents and without parental care; beneficiaries of social or permanent financial support; persons affected by natural disasters; disabled persons and persons that depend on the other persons care; socially vulnerable categories of the Roma population (according to the Roma Strategy) and self-sustained parents with minor children. The monthly rent for usage of the social apartments is not more than MKD 15 per square meter.

### **General requirements to buy /rent real estate**

To rent a house or an apartment the landlord and the tenant must conclude a lease contract that needs to be certified by a notary. The landlord is obliged to pay income tax (10%) of the rented amount. The tenant is obliged to pay for electricity, water, heating and to conduct all small repairs as

a result of the apartment's regular usage. In most of the cases, upon the conclusion of the leasing contract, the tenant has to pay at least two months of rent in advance.

The commercial banks offer various credit opportunities for the persons interested to buy a real estate. The conditions for approving a loan depend on the assessed credit ability of the applicant, but generally the loans are given under the below conditions:

- The credit for purchase of real estate can amount from EUR 5000 to EUR 150.000
- The interest rate on the loans varies from 6%-7%
- The applicant has to be employed and should prove his/her ability to pay the credit instalments
- Mortgage of the real estate
- 1/3 of the applicant's salary should be equal or higher than the monthly instalment
- 2 guarantors with credit ability, employed in company or institution acceptable for the bank

The contract for buying real estate has to be concluded writing and it must be certified and stamped by the public notary. The purchase of real estate includes the sales tax which in accordance with the Law on Property Taxes is from 2- 4% of the market value; The seller is responsible to pay the tax, unless in the contract for purchase it is indicated that the sale tax will be paid the buyer. The buyer should register the real estate with the Cadastre Department at the State Office for Geodesy Affairs which issues the Property list to the new owner.

### **Example of rental fees for a two-room-apartment/house in the capital, a big city, rural areas and other places of interest**

Monthly rental fees for two-room apartment for different towns:

- Skopje: EUR 150-250 (the rental fees depend on the location of the apartment; the monthly rent for apartments in the city centre are higher)
- Kumanovo: EUR 110-150
- Bitola: EUR 110-150
- Tetovo: approximately EUR 130
- Prilep: approximately EUR 100

## **Education**

### **General description of the education system**

The Macedonian educational system is organized into four levels of formal education: pre-school, primary, secondary and higher education. On the basis of the amendments of the Law on Primary Education adopted on 20 September 2004, primary education is compulsory for all children in the age group 6-15 years.

In accordance with the amendments introduced on 29 May 2007, the primary education lasts for nine years divided in to three three-year cycles. According to the changes and amendments of the Law on Secondary Education adopted on 18 April 2007, secondary education is compulsory and free of charge in the public education institutions.

The University Education is delivered through 5 public universities with 63 faculties, 10 private universities with 60 faculties, 6 independent universities and 2 universities of the religious

communities (State Statistical Office, 2008). The list of accredited universities is available at the website of the Ministry for Education and Science <http://mon.gov.mk/aktivnosti/597>.

### **Access to education for returnees**

The legal provisions in the field of education grant free primary education in the public education institutions. Free of charge books for the primary school pupils, as well as free of charge transportation for the pupils who live farther than 2km from the school are granted.

The parents are legally obliged to enrol the child who is/will turn 6 years of age by the end of the calendar year. Exceptionally, the child can be enrolled to elementary education if it turns 6 years of age by 31 January the next calendar year. If the child is not prepared, the enrolment in the elementary education can be postponed based on the parent's request and confirmation from the health institution.

### **Primary education**

The enrolment in primary education takes place in May and the school year begins in September. The following enrolment documents should be submitted to the primary school:

- Birth Certificate
- Vaccination certificate

Children with foreign citizenship or without citizenship residing in Macedonia are entitled to primary education under the same conditions as the Macedonian children. For a successful inclusion in the education process, children who resided abroad are provided with individual and group support in learning the Macedonian language and other related subjects.

### **Secondary education**

With the changes in the Law on Secondary Education, the secondary education became compulsory for all citizens. Free of charge books for all secondary school students, as well as free of charge transportation for the students, when necessary, is granted.

A person who is not older than 17 years can be enrolled as a full time student in the public secondary education, while the age limit for persons with disabilities is 25 years of age. The candidates interested to enrol as a part time students in the secondary education have to fulfil the following criteria: to be older than 17 years of age, and to be on a sick leave for a longer period of time. The candidates that completed elementary education abroad can enrol in the secondary education upon the recognition of the elementary education diploma.

Enrolment documents for secondary education:

- Application form (available at the secondary school)
- Original primary education certificates for V to VIII grade
- Birth Certificate

The Law defines secondary education as follows: gymnasium (general secondary education), vocational training, secondary art education and secondary education for students with special needs.

### **Types of Secondary Schools**

- Pupils that completed elementary education can enrol in the *Gymnasium*. The duration of the Gymnasium is four years.
- Pupils that completed elementary education can be enrol in vocational training. The duration of the vocational education is 3 or 4 years. The Vocational Education also includes specialized education with 2 years duration. The Specialized Vocational Education is also available for candidates without completed elementary education; in parallel with the Specialized Vocational Education, the students have to complete the elementary education programme.
- The Secondary Schools of Arts is available to pupils interested to study arts, music or ballet. Talented applicants without completed elementary education can enrol in Secondary Schools of Arts with approval by the Ministry of Education. However, in parallel these students must complete the elementary education programme.
- Secondary Education for students with special educational needs is available to pupils with development disabilities.

The private secondary schools are based on the principle of self-financing. The average fees for one school year are from EUR 2000 to EUR 5000. For more information on the private secondary schools and possibilities for scholarships please visit the following links:

### **Education for adults**

The educational process for adults is carried out in special classes within the regular elementary schools and worker's universities. The only specialized central elementary school for adults, with several local units is the school "AS Makarenko". The Secondary education for adults is an integral part of the regular educational process in the high school institutions. The secondary education for adults is carried through the existing secondary schools, where the school programme is organized for adults as part-time students in all profiles (according to Article 47 and 48, Law on high school education).

### **University**

Persons who completed secondary education and passed the state graduation exam (државна матура) can enrol in university education. The University has the autonomy to define the procedures for selection of students interested to enrol in the first year of university education. In line with the Law on University Education, the Public University can introduce participation in the cost for studying



for the students whose studies are covered by the State Budget. The students pay the participation in equal instalments at the beginning of every semester. The participation fees for the students whose studies are funded by the state budget are EUR 200 per year, while for the dispersed studies the participation is EUR 100 per year. The fees for the students that are not in the state quota (those who are covering the fees by themselves) are not more than EUR 400 per year.

The studies at the private universities are based on the principle of self-financing. The approximate fees for one academic year are EUR 2000.

Enrolment documents:

- Application form
- Diploma for passed state graduation exam
- Birth certificate
- Citizenship
- The candidates applying for part- time studies should also submit -Form M1 and M2 certified by notary, medical confirmation published by the health care institution and/or prove that the candidate is on a maternity leave
- Confirmation for payment of administrative fees

### **Recognition of foreign diplomas**

The Macedonian citizen who has completed elementary education (or a grade of the elementary education) abroad has a right to request recognition of foreign diplomas in line with the Law on Elementary Education.

The institution responsible for the recognition of foreign diplomas is the Ministry for Education and Science. During the recognition procedure, the following factors are considered: education system of the country that issued the diploma; duration of the education; the educational plan and programme; the rights acquired by the diploma holder in the country that issued the diploma; and other factors which are considered as important during the recognition procedure.

In addition to the request for recognition, the applicant has to submit the original diploma issued by the accredited foreign primary school and translation of the diploma in three samples. The translation must be provided by an authorised translator. The Ministry for Education might require additional evidence which would further provide indications on the applicant's education.

The procedure for recognition of secondary school diploma is regulated by the Law on Secondary Education and is identical with the procedure for recognition of elementary education diplomas.

The Law on University Education defines the procedures for recognition of university diplomas. The applicant should submit a request for recognition of the university diploma to the Ministry for Education and Science. The Information Centre verifies the validity of the original documents, and examines the background of the institution that issued the diploma. In addition to the necessary documents, the applicant should also submit a signed statement that the documents are valid in line with the legal regulations of the country that issued the diploma. The recognition is done by an Expert Commission established by the Educational Council of the relevant university. If during the recognition procedure is assessed that the educational plan and programme are significantly different from the educational plan and programme of the relevant university, the applicant will have to pass additional exams.

## **Vocational training possibilities, scholarship and grants**

The vocational training institutions organize vocational trainings in professions which are demanded by the labour market. As a precondition for enrolment to a certain vocational training programme, the candidates must have completed elementary education, while for some vocational training programmes the elementary education is not a precondition. The average duration of the vocational training programmes is 4 months and the average enrolment fees vary from EUR 300 to EUR 800. Upon the completion of the vocational training the candidates are provided with certificate for the acquired qualifications.

The Governmental Operational Plan for Active Programmes and Measures for Employment 2012-2013 envisages free of charge vocational trainings in professions that are demanded by the labour market. The duration of the vocational training programme is 3 months and is organized by certified institutions. Upon completion of the vocational training, the candidates are referred to on the job training at identified companies for an additional month. The programme is available for persons that are registered as unemployed at the Employment Service Agency and that have not been beneficiaries of this programme previously. The Roma population is identified as a priority group within the Governmental Plan for Active Programmes and Measures for Employment.

Of particular importance are the scholarships for Roma enrolled in the first, second, third or fourth year of secondary education. The beneficiaries of this programme are Roma students whose average mark in the previous school year was at least 3,00. The monthly amount of the scholarship varies from MKD 1500 to MKD 2200 (CHF 30-45) and depends on the students' average mark in the previous school year. The scholarships are being provided by the Macedonian Government and the Roma Education Fund.

Medical Scholarships for Roma: The programme provides support to Roma students enrolled in the accredited secondary schools and universities of medicine in Macedonia, Bulgaria and Serbia. The scholarships are available for the students interested to study in their domicile country or in the country of residence. The students selected for scholarship can also apply for language courses and participate in the mentorship and advocacy programme organized by the Institute for Open Society. The scholarships are being provided with support of the Roma Education Fund and Open Society Institute. Scholarships for university studies for students enrolled in public and private universities: In order to be eligible for scholarship, the students should fulfil the general following criteria:

- Regular student
- Macedonian citizen
- A student who has not repeated an academic year;
- A student who is not a beneficiary of scholarship or credit from other institutions and organizations;
- A student not older than 22 years of age in the second academic year.

This programme includes three types of scholarships: Type A-Scholarship of the Minister for Education and Science for talented students; Type B-Scholarship for students and Type C-Scholarship for students of social categories.
